## **The application process for TANZPAKT is online! Applications for the fourth funding round can be submitted from April 1st**

Following the decision to continue the initiative by local authorities, federal states and the Federal Government Commissioner for Culture and the Media (BKM), dance professionals will be able to submit applications for the new funding round of the TANZPAKT Stadt-Land-Bund programme from 1 April 2025.

In addition to the opportunity to receive individual advice, the supporting institutions are offering two online appointments in which they will present the programme and answer questions about the application process:

### **Call for applications 2025**

Application start: 1 April 2025  
Application deadline: 22 September 2025, 6 p.m.  
Jury decision: November 2025  
Project start: from 15 November 2025 with a standard duration of 36 months  
Project end: 30 June 2030 at the latest

The jury has already been finalised and is made up of Angela Alves, Carmen Kovacz, Sebastian Matthias and Katharina von Wilcke.

The application deadline for the fifth funding round is planned for spring 2027 - the exact date will be published in good time on the website and in the newsletter.

The funding programme is implemented in cooperation between Bureau Ritter (funding fund) and the Dachverband Tanz Deutschland (cultural-political dialogue). The aim of the excellence funding programme is to strengthen the art form of dance both artistically and structurally in the long term. TANZPAKT Stadt-Land-Bund enables long-term collaborations and innovative development concepts and is aimed at artists, ensembles, production structures and networks.
